

Whitingham Library Board of Trustees Meeting Minutes

September 17, 2025

5:45 pm Meeting called to order.

The September 6th meeting was canceled due to a lack of trustees and was rescheduled for September 17th.

Wendy made a motion to approve the August minutes, Judy seconded, all approved.

Discussions:

Kristine explored options within the community to ensure the annual Halloween Specials could continue. Because construction has made the library inaccessible to the public, this year's events will take place in Jacksonville. The pumpkin contest will not be held. The Trunk-or-Treat will be held in the Rt. 112 parking lot, and the Haunted House will be set up at Engle House across the street. Kristine also confirmed that the certificate of insurance will cover these off-site events.

The Holiday Kids Bazaar is scheduled for either December 6, 2025, or December 13, 2025. We are requesting additional donations, with a particular need for items suitable for men.

Carpet cleaning is planned for the week of Thanksgiving; however, a company has not yet been secured to perform the work.

Kristine researched options for awning {to the potential deck}, with an estimated cost of approximately \$14,000. Funding should be sufficient to cover both the deck and the awning. The deck installation will require approval from the town.

Kristine and Lois will prepare the mailings for the annual appeal. However, the large machine used for printing and folding cannot be removed from the library. Wendy made a motion to outsource the printing and folding, giving Kristine the discretion to proceed if it is cost-effective. Judy seconded the motion, and it was unanimously approved. Wendy made a motion to adjourn the meeting at 6:06pm. Judy seconded, all approved. The next meeting is October 1, 2025 online.
