

**SCHOOL WARNING  
TWIN VALLEY UNIFIED UNION SCHOOL DISTRICT**

The legal voters of the Twin Valley Unified Union School District are hereby notified and warned to meet at the Twin Valley Elementary School library in said Town of Wilmington, Vermont, on Tuesday, February 25, 2025, at 6:00pm to act on Articles I, IX and X of the School District Warning, directly followed by a Budget Informational Meeting.

The meeting will then be adjourned until Tuesday, March 4, 2025, for voting on Articles II-VIII by Australian Ballot.

- ⦿ In Whitingham, at the Twin Valley Middle High School Gymnasium, polls open from 10:00 am until 7:00 pm

**ARTICLE I**

Shall the Twin Valley Unified Union School District vote to appoint a moderator for the annual meeting?

**ARTICLE II**

To elect a Moderator, by Australian Ballot.

**ARTICLE III**

To elect a Clerk, by Australian Ballot

**ARTICLE IV**

To elect a Treasurer, by Australian Ballot.

**ARTICLE V**

To elect (3) School Directors, for two (3) year terms and one one (1) year term remaining.  
To be voted by Australian Ballot.

**ARTICLE VI**

Shall the voters of the Twin Valley Unified Union School District approve the School Directors to expend \$11,149,882 which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in per pupil education spending of \$14,261, which is 2.72% higher than per pupil education spending for the current year. To be voted by Australian Ballot.

**ARTICLE VII**

Shall the voters of the Twin Valley Unified Union School District authorize the School Directors to allocate \$592,246 of the FY 2024 Fund Balance to the Maintenance Reserve Fund for the purpose of maintaining the facilities and/or emergency repairs? To be voted by Australian Ballot.

**ARTICLE VIII**

Shall the voters of the Twin Valley Unified Union School District authorize the School Directors to apply \$350,000 of the FY2024 Fund balance to the FY 2026 revenue?  
To be voted by Australian Ballot.


**ARTICLE IX**
